2. Sou 'n rekening betwis word, mag betaling daarvan nie weerhou word tot die twis besleg is nie.
3. 'n Rekeningnommer moet genoem word met elke rekeningnavraag.
4. Voor met verlof, besigheidsbesoek, ens., vertrek word, is dit noodsaaklik om vir vereffening van rekeninge te reel.
5. Versoeke om adresverandering word nie telefonies aanvaar nie.
6. Indien 'n klient geen rekening ontvang het tot op die 10de van die maand nie, moet 'n afskrif verkry word by die munisipale kantore.
7. Indien die elektrisiteit, water en vullis nie betaal is teen die sluitingstyd voor of op die "laaste datum vir betaling" nie, sal dienste sonder kennisgewing gestaak word.
8. Rente teen prima plus een persent sal gevorder en verhaal word vanaf die eerste dag na betaaldatum.
9. Indien 'n klient van adres verander sonder om die Raad skriftelik daarvan in kennis te stel, sal alle opsporingskoste van die klient verhaal word.

IMPORTANT

1. No cheques will be accepted for payment to the Witzenberg Municipality.
2. Should any account be disputed payment may not be deferred pending settlement of the dispute.
3. When querying any account the account number must be provided.
4. Before leaving on holiday, business etc., it is essential to arrange for settlement of accounts.
5. Change of address requests will not be accepted telephonically.
6. If no account is received by the 10th of the month, a copy must be obtained from the Municipal Office.
7. If the electricity, water and refuse are not paid by closing time on or before the "last date of payment" services will be discontinued without further notice.
8. Interest at 1 (one) percent above Prime Rate shall be recovered from the first day following the due date.
9. Should a consumer neglect to notify Council in writing of any change of address, all tracing charges will be for the debtor's account.
